Proposed September 2022 Service Adjustments

SacRT is proposing changes to 19 bus routes, which would take effect on Sunday, August 28, 2022 (unless otherwise noted). The 19 bus routes with proposed changes include routes 1, 23, 26, 30, 33, 38, 51, 81, 82, 86, 93, 107, 134, 138, 142, 177, 193, E37 (new route) and E110. SacRT accepted public comment on these proposed changes through May 1, 2022.

On Monday, May 9, 2022, the SacRT Board of Directors will consider these proposed service changes for September 2022 for approval. Visit sacrt.com/septemberservice for the latest information and to review the report.

The report provides a discussion of temporary changes that took effect on April 3, 2022, in response to an ongoing shortage of bus operators, temporarily reducing bus service levels to a level that can be operated more reliably. It recommends most (although not all) of those temporary reductions be restored on Sunday, August 28, 2022. It also recommends several minor, low-cost improvements to other routes at that time, which were recommended in SacRT's Short-Range Transit Plan. Lastly, it presents and discusses multiple potential partnerships for future service that could be funded via cost-sharing agreements. A Title VI service equity analysis of the temporary April 2022 suspensions and of all potential changes is included in the report.

SacRT on the Move: SacRT's Short-Range Transit Plan Update

SacRT's Short-Range Transit Plan (SRTP) draft document is nearing completion, and staff plans to present the information to the SacRT Board of Directors during the board meeting on Monday, May 9, 2022. The public actively participated during SRTP virtual events and public meetings, making public engagement efforts a huge success. SacRT received over 90 comments, which have all been analyzed and considered for potential final changes to the draft document. All comments have also been included in the public comment record, which will be presented with the SRTP document to the Board of Directors.

We listened! As a result of comments received, the following has been updated in the Five-Year Service Plan:

- A new service concept has been added to provide fixed-route bus service to Duckhorn Boulevard in the North Natomas area. This area has been without transit service due to low demand; however, as developments continue to grow and more individuals reside near this area, SacRT felt the need to include this as a planned service improvement for the next five years.

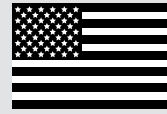
SacRT Fiscal Year 2023 Preliminary Budget Public Hearing

SacRT's Fiscal Year 2023 Preliminary Operating and Capital Budget is now available for public review and comment at sacrt.com/budget. SacRT will hold a virtual public hearing on the proposed budget via YouTube and Zoom on Monday, May 9, 2022, during the regularly scheduled SacRT Board of Directors Meeting. The annual May is Bike Month tradition continues this year! Bike riders across the region can take advantage of the spring weather and leave their cars at home. Riders can sign up to participate, log their trips and earn prizes at lovetoride.net.

Transit and bikes make a great team. All SacRT buses have bike racks on the front that can hold two or three bikes. Bikes are also allowed inside light rail trains; however, persons boarding light rail trains with a bicycle should not board using the mini-high ramps, as they are reserved for use by persons with disabilities. In addition, SacRT requires passengers with bikes to leave space available at the front of the first train car for riders with disabilities. Coming Soon: SacRT Bus Stop Improvement Survey

SacRT is partnering with Civic Thread, a local non-profit planning and advocacy organization, to complete a Bus Stop Improvement Plan for the SacRT service area, which includes the cities of Citrus Heights, Elk Grove, Folsom, Rancho Cordova, Sacramento and Sacramento County. This plan will create a comprehensive list of necessary and desired improvements to bus stops, amenities, and supporting pedestrian infrastructure.

Bus stop improvements will be identified through a community survey available to all residents within SacRT's service area that will allow respondents to express their concerns about what bus stops need to be prioritized for improvements. This information is being gathered with the intention of directing future funding for bus stops towards areas of the highest priority.
