#### March 2021 FY 2021 - Key Performance Report

#### Management Notes:

- The information in this report is based on the FY 2021 Operating Budget, amended by the Board on March 14, 2021.
- March 2021 performance was greatly impacted by COVID-19 pandemic.
- Due to COVID-19 pandemic, systemwide ridership for the month of March compared to the same period last year decreased by 45.5 percent, rail ridership decreased 49.6 percent and combined bus ridership decreased 41.4 percent. Year-to-date, systemwide ridership compared to the same period last year decreased 62.7 percent, rail ridership decreased 64.8 percent and combined bus ridership decreased 60.4 percent. In relation to the District's established year-to-date ridership goals for FY 2021, systemwide ridership was 29.4 percent below the established goal, rail ridership was 35.5 percent below the goal, and combined bus ridership was 22.6 percent below the goal.
- RT's farebox recovery ratio in the month of March was 6.4 percent and year-to date it is 6.4 percent. It has
  decreased by 6.2 percent compared to March 2020 and decreased by 8.3 percent year-to-date. In relation to the
  District's established goal for FY 2021, the RT's farebox recovery ratio is 0.1 percent below the established yearto-date goal. For the month of March, Fare Revenue was \$1.0 million and above seasonally adjusted budget by
  \$0.05 million or 5.6%. Compared to last year, Fare Revenue is \$9.8 million or 52.6 percent below last year-to-date
  total.
- In March 2021, total operating cost was \$15.98 million including \$7.21 million for bus, \$0.16 million for CBS fixed service, \$0.65 million for SmaRT Ride service, \$1.54 million for SacRT GO service, \$5.97 million for rail, \$0.45 million for Elk Grove e-tran service.
- Year-to-date, RT's cost per passenger for bus service was at \$27.21, and cost per passenger for rail service was at \$19.17. Light Rail cost per passenger is 51.5 percent over budget, and bus cost per passenger is 19.9 percent over budget.
- Year-to-date, RT's passengers per revenue hour is below the District's goal by 22.0 percent for rail, by 22.7 percent for Bus and for CBS, it is 0.8 percent above budget.
- RT monitors the overall performance of the fleet to evaluate potential failure trends. In the month of March, combined bus service was reported at 12,375 miles between service calls, and rail service was reported at 13,265 miles between service calls.
- Year-to-date, RT's on-time performance for bus service is at 84.7 percent, which is 7.7 percent above the District's goal of 77.0%. On-time departures for rail service are at 97.9 percent above the goal of 97.0 percent. Completed trips for CBS are 0.13 percent, for Light Rail are 0.13 percent above the District's goal, and for bus it is 0.13 percent below the goal.
- The District's security statistics from RT's Police Services indicate a passenger inspection rate of 26.31 percent for the month of March 2021 compared to 18.22 percent in March of 2020.

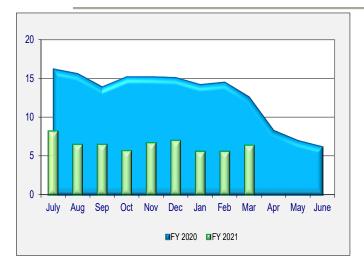

# **Operating Budget**

Net results for FY 2021 year-to-date indicate a \$7.0 million positive variance to the District's FY 2021 Operating Budget. As of end of March 2021, year-to-date operating costs were under budget by \$9.0 million and revenues were below budget by \$2.0 million.

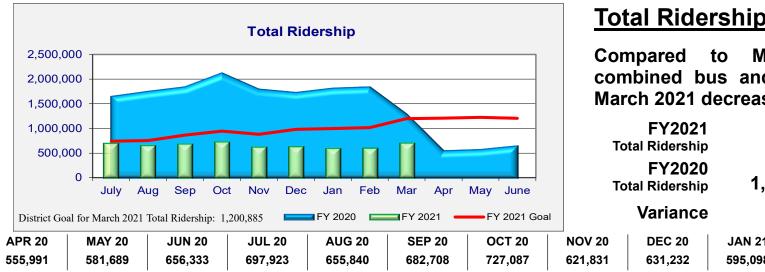


### Fare Recovery Ratio

Compared to March 2020, the fare recovery ratio for March 2021 decreased by 6.2 percent.

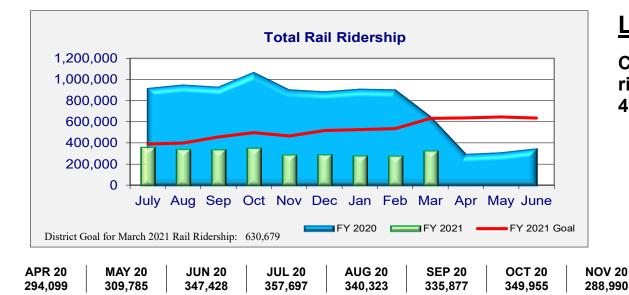

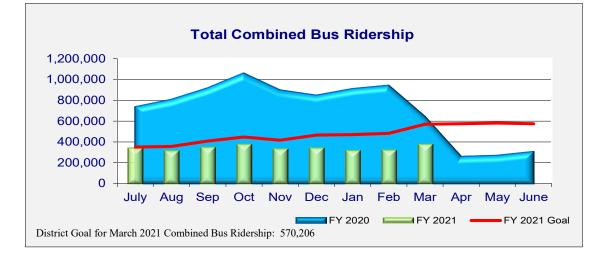

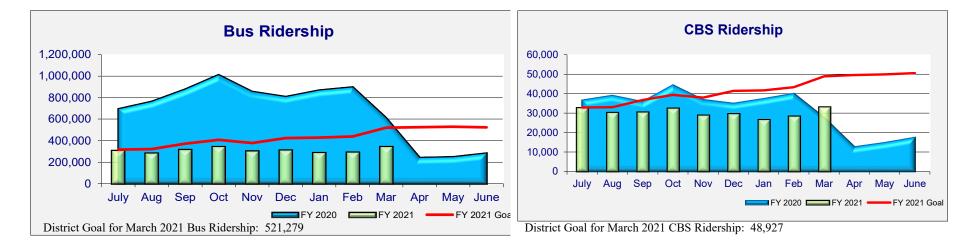

#### **Combined Bus Ridership**

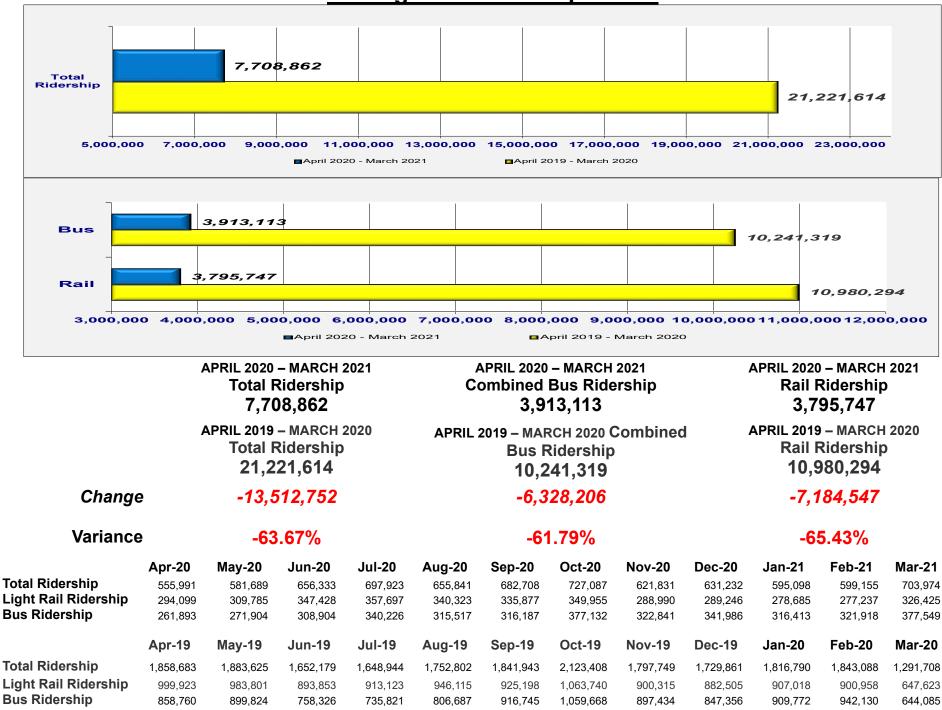
