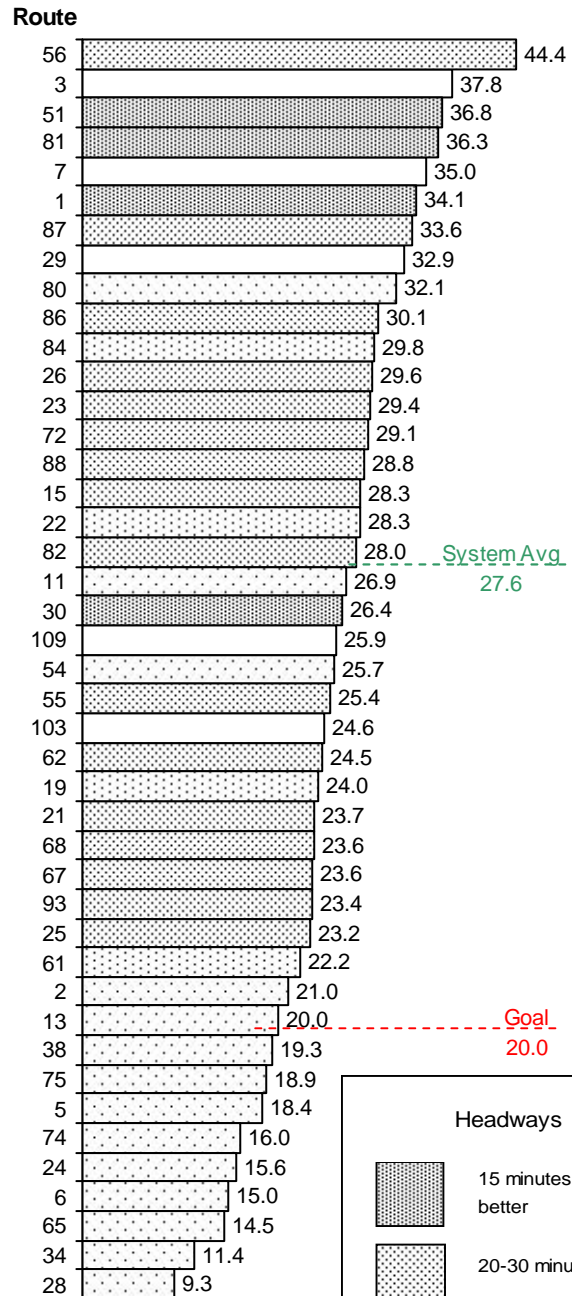

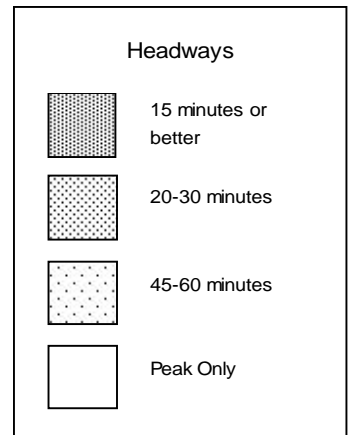
- Route 75 boarding's per hour went down 41% from 32.2 to 18.9
- Route 28 was extended from Cordova Town Center light rail station to Mather Field/Mills light rail station in January 2014. Ridership has not changed. Revenue hours increased by 15%, but actual operating cost was unchanged due to scheduling efficiencies.
- After six quarters of being below productivity, Route 13 Northgate is now at goal (20 boarding's per revenue hour).
- Route 24 productivity has increased to 15.6 from 11.6 for the same period one year ago. Service span was improved in January 2013.

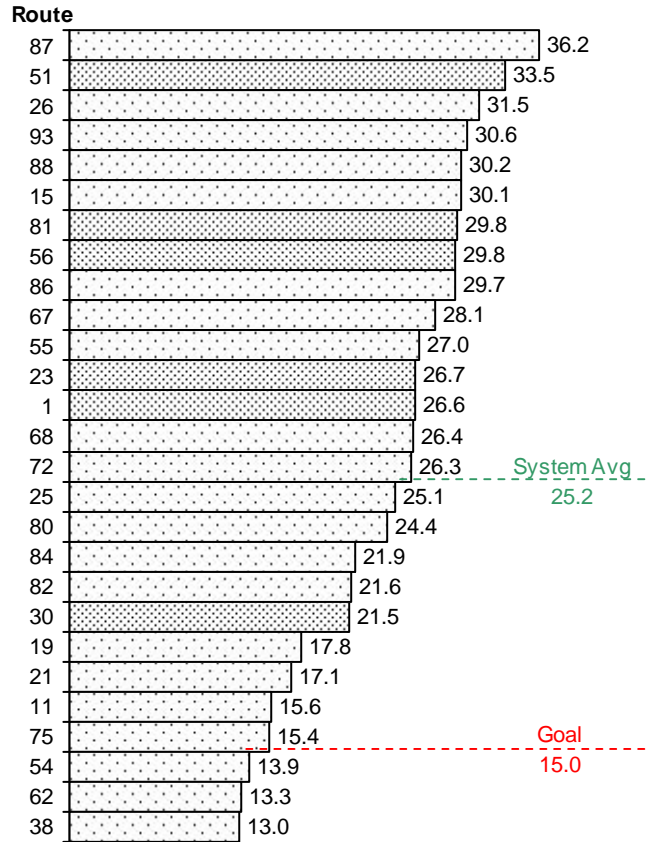

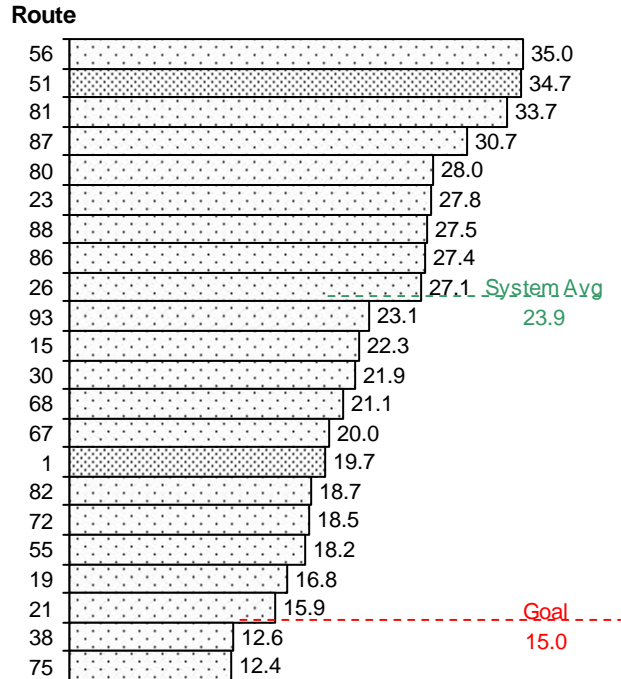

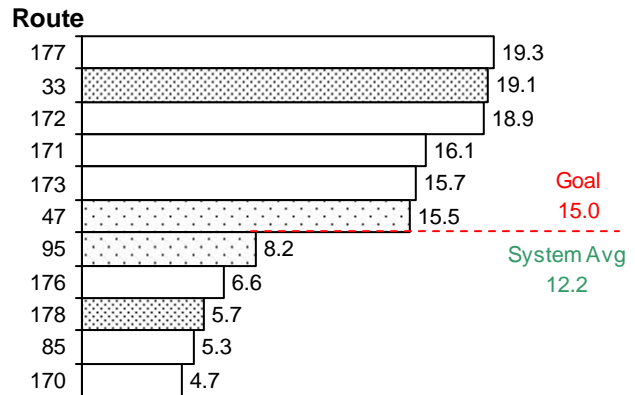

Newly created routes that do not meet minimum productivity standards within two years are subject to automatic elimination pursuant to RT's route sunset process.

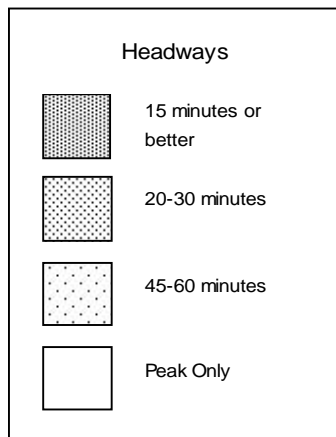
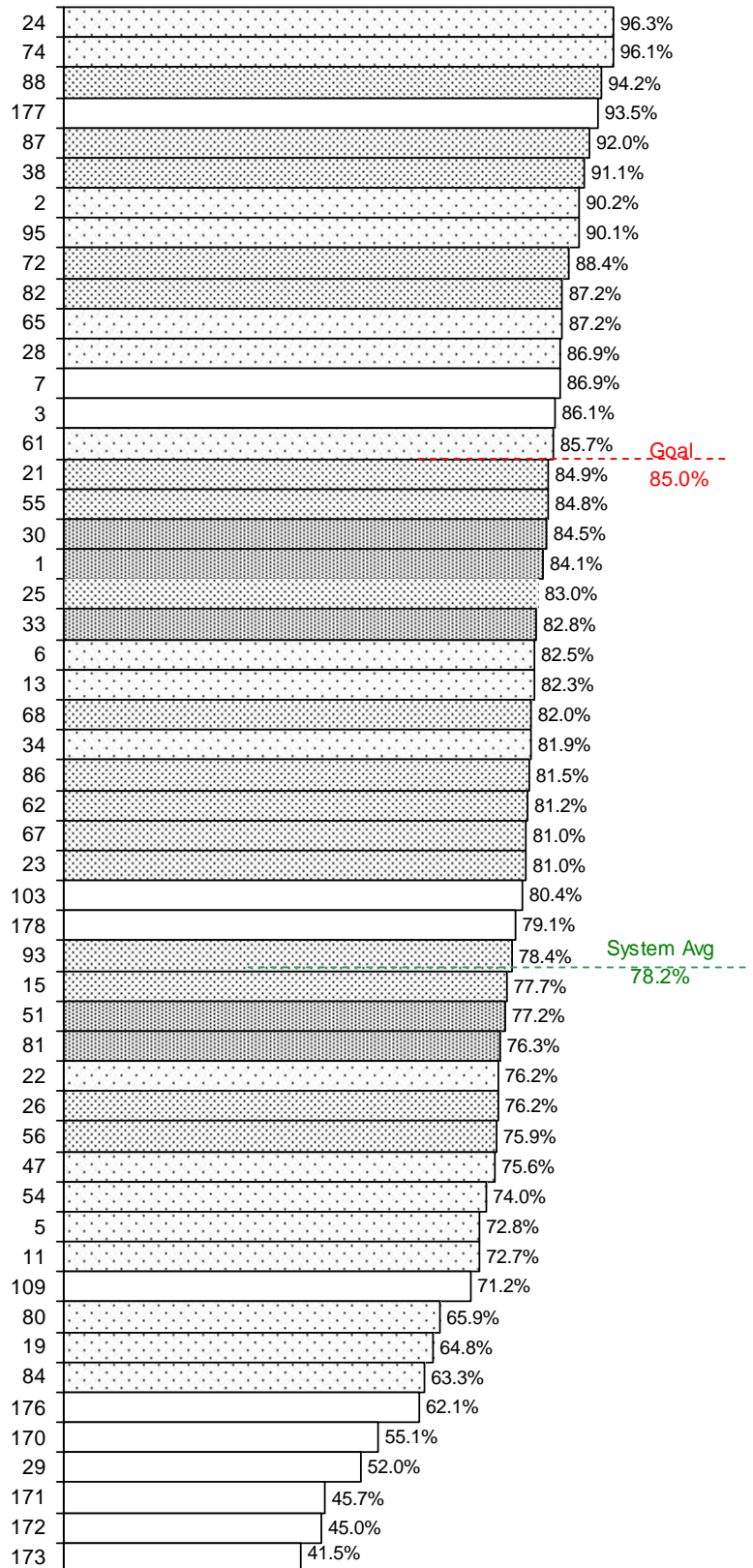

A bus is considered on-time if it leaves its time point 0-5 minutes late. On-time performance indicates the percent of time points where the bus was on-time according to this definition.

Weekday on-time performance is close to 7 percent below RT's goal of 85.0 percent. System wide on-time performance was 78.2 percent, up from last period.

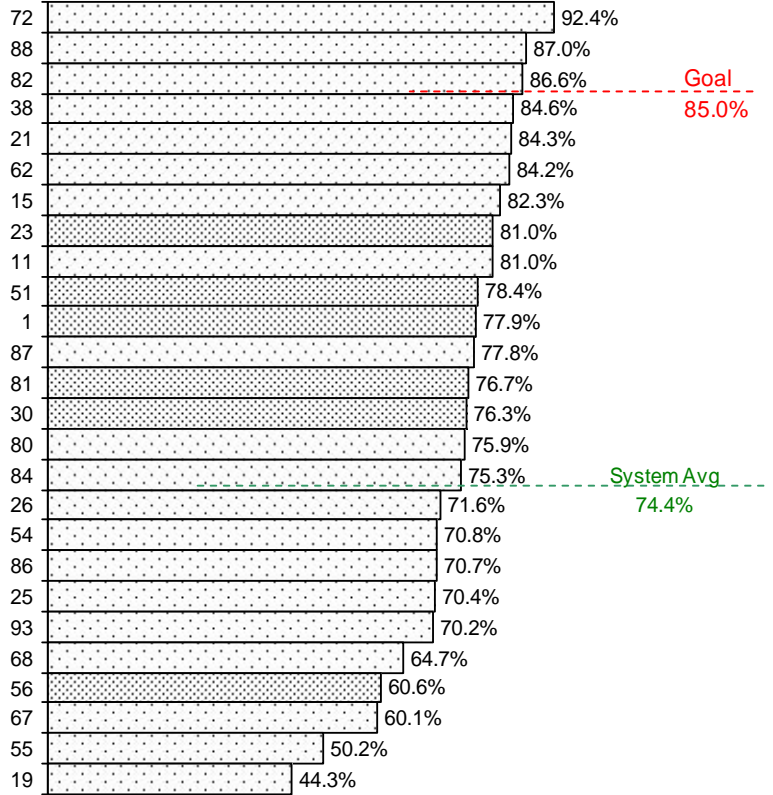

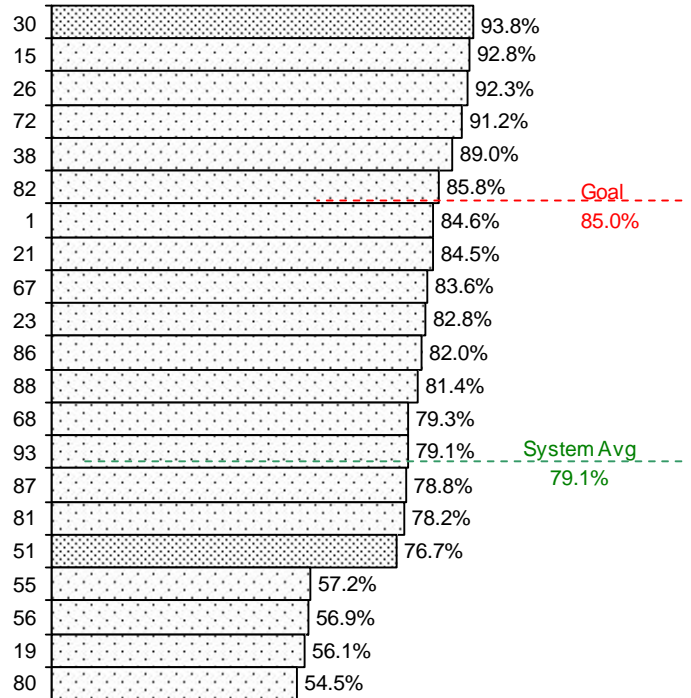
